

FOOD ASSISTANCE (SNAP - Supplemental Nutritional Assistance Program)






OWF (Ohio Works First) CASH ASSISTANCE





431 families received OWF assistance.







CCDJFS received 2 Competitive Efficiency and Innovation grants for Adult Protective Services: one to provide homemaker services for the elderly and the other to recruit and support guardians for elders found to be incompetent by a court of law.



SENIOR CITIZENS SERVICES LEVY

Voters passed the Senior Citizens Services Levy on November 3, 2015.

The .5 mil levy will generate approximately \$800,000 and will provide funding to assist Columbiana County's growing senior population with much needed services including public guardianships, legal counsel, homemaker/chore services, extermination services, dumpster services, and friendly visitor services.

On November 25, 2015, the Board of County Commissioners designated the Columbiana County DJFS as the Administrative Agent for the levy. On December 23, 2015, County Commissioners appointed a Senior Citizens Services Levy Advisory Board to advise CCDJFS in matters pertaining to the administration of the levy. Those appointed:

Collections of the levy will begin in the Spring of 2016.

SENIOR COMMUNITY SERVICE EMPLOYMENT PROGRAM

SCSEP is a major program of the Older Americans Act which celebrated its 50th anniversary in 2015. Administered by the U.S. Department of Labor, it is the only federal government program mandated to assist unemployed older adults seeking to rejoin the workforce.

Columbiana County DJFS began administering the local program in July of 2011. In 2015, there were 20 participants earning minimum wage for 20 hours per week. Payroll budget for July of 2015 through June of 2016 is \$146,854.00.

10 host agencies employ the senior participants: The Way Station of Columbiana & East Liverpool; Catholic Charities, The Community Resource Center, Salem Parks & Recreation, Home Care Advantage, Columbiana County Engineer's Office, Wellsville Village, Family Community Services, and Community Action Agency's Head Start Program.
